REQUIREMENTS FOR SUBMISSION OF A SUBDIVISION CERTIFICATE APPLICATION

The following information must accompany an application:

- original plan of subdivision prepared by a registered surveyor and 10 copies of the original plan;

and, where applicable:

- if the construction certificate was not issued by Council, detailed subdivision engineering plans endorsed with a construction certificate from the private certifier;
- evidence that the applicant has complied with all conditions of consent that are required to be complied with before a subdivision certificate can be issued;
- a certificate of compliance from the relevant water supply authority;
- if a subdivision is the subject of an order of the Land and Environment Court under section 40 of the Land and Environment Court Act 1979, evidence that required drainage easements have been acquired by the relevant council;
- for subdivision involving subdivision works evidence that:
 - the work has been completed, or
 - agreement reached with the relevant consent authority regarding payment of the cost of work or as to the time for carrying out the work, or
 - security given to the consent authority with respect to the completion of the work.
